14/089 Co-option of a member to fill a casual vacancy

Following Nigel Budd's request to retire and posting of the required notices, there had been one application to fill the casual vacancy. After a vote it was unanimously agreed that Mr Wayne Mouring be co-opted onto the Parish Council.

The Chairman thanked Nigel for all his work as a parish council member and it is hoped he will go on supporting the village.

14/090 Declarations of Interest

There were no declarations of interest pertaining to agenda items.

14/091 Minutes

The minutes of the meeting of the Parish Council held on 5th June 2014 were approved as a correct record of the meeting and signed by the Chairman.

14/092 Clerk's report on progress

Regarding new playground equipment, the Clerk advised that she was double-checking the spec and installation costs and had arranged to meet two playground manufacturers for additional quotes before proceeding. The Clerk would also apply for S.106/PIC funding.

Ben has been spending more time weeding at Jubilee Pond and the Clerk would continue to monitor.

14/093 Chairman's report

There was nothing to report that wasn't covered elsewhere on the agenda.

14/094 Report from Waverley Borough Councillor

Mrs Foryszewski had sent her report, which is appended to these minutes.

14/095 Waverley Borough Council New Local Plan Consultation

Waverley Borough Council is conducting a consultation on its new Local Plan Part I, which runs until 17th October, and are looking to get responses from as many Waverley residents as possible. The previous 'Core Strategy' submitted

for examination in January 2013 was rejected by the Inspector mainly on the grounds that it did not provide for sufficient houses to be built in the plan period. A Strategic Housing Market Assessment was carried out which suggested that 470 homes per annum would be required during the plan period. The current consultation concerns where the additional homes should be built, including on sites within the Green Belt and outside settlements, including Dunsfold Park. The consultation links and documents had been circulated prior to the meeting.

The Chairman advised that she and Mrs Mayne and the Chairman and Vice Chairman of Dunsfold Parish Council had met with Cllrs Victoria Young, Surrey County Councillor and Alan Young to discuss the consultation. Surrey CC's response will consider infrastructure and sustainability issues, and the Councillors wanted feedback from residents.

The Chairman stressed the importance for as many Alfold residents as possible to respond to the consultation. Waverley would be sending out a special edition of Making Waves, which would include a feedback form. The Clerk would contact Waverley to ensure copies are sent to Alfold properties within the RH postcode area. WBC would be holding a public exhibition in Alfold Village Hall between 5pm and 7pm on Wednesday 1st October. It was agreed that the parish council would meet the same evening in order to consider and agree its draft response, a public meeting would then be held on Wednesday 8th October for residents to give their views to the parish council before its response is finalised.

14/096 Neighbourhood Plan Update

Mr Deanus proposed setting up a Steering Group to coordinate all the different facets of work that would be involved in producing the Neighbourhood Plan. In addition to members of the parish council, it was agreed that Alasdair Denton-Miller, James Northcote-Green, Mike Padfield and Hayley Ringrose would join the Steering Group. The Clerk will proceed with setting up a meeting with Chris Bowden of Navigus Planning during November.

14/097 Dunsfold Road Footpath - Update

Adrian Selby, Surrey Highways Senior Engineer, had confirmed that progression of the scheme would be via the Cranleigh and Eastern Village Task Group, which the parish council would attend to put forward its case. Funding would also be sought from S106 where available.

14/098 Clerk's Contract of Employment

The Clerk had been keeping timesheets for a year, which showed an average of 11.2 hours per week spent working for APC. The Chairman proposed that the Clerk's paid hours be increased to 11 hours per week, which was agreed. A Home Office and Equipment Allowance was also discussed and proposed by Mr Pidgeon it was unanimously agreed that this would be paid based on SSALC recommended calculations.

14/099 Correspondence

The parish council had been copied in on correspondence between Waverley BC and Dunsfold Park concerning publicised Top Gear Experience Days. Dunsfold Park are to advise under which permissions they believe the activities will take place and if this is not satisfactory WBC will be required to take enforcement action.

The parish council had received responses from the CAA and Anne Milton MP following its letter to Gatwick Airport Ltd criticising the Airspace Consultation process. They said that it is their job to look at all the routes and would be looking into the process of the consultation. Mrs Milton said that she had received many letters of complaint from residents and had passed these onto the Minister for Transport.

Richard Cooke had written to advise that the outline S106 agreement for the Chapel Fields application, if approved, only contained Cranleigh based projects. It was agreed the Clerk would find out how to get Alfold's projects considered for S106 funding.

Clerk

The Clerk had received a reply from Waverley's Tree Officer concerning the forestry work in Rosemary Lane, to say that this was being carried out under licence with the Forestry Commission.

RE: WA/2014/1518 Erection of 2 detached dwellings and associated works including formation of new access following demolition of existing buildings (follows invalid application). Land Adjoining Byways, Dunsfold Road, Alfold GU6 8JB.

Alfold Parish Council has no objection to this application. However, as previously communicated to the applicant and in our letter in response to the previous applications, the parish council would prefer to see a pair of semi-detached dwellings in order to be more in keeping with the adjacent properties. The parish council would also be keen to see an alternative method of sewage discharge other than into the main sewer network, which is already acknowledged by Thames Water and Southern Water to be at capacity.

The parish council would require that the land to the east of Cottage 1 is included as amenity land for Cottage 1.

RE: WA/2014/1468 Change of use of builder's store to storage of vehicle parts and equipment; erection of building for MOT vehicle testing and builder's storage following demolition of agricultural store.

Alfold Parish Council has considered this application and OBJECTS.

The parish council considers that the change of use for MOT vehicle testing would cause an increase in the intensification of car usage of the site as it is inevitable there would be an increase in the number of vehicles for general MOT vehicle testing. Therefore, the parish council does not agree with the applicants claim that traffic movements would be reduced.

The application site is very close to the dangerous junction with the A281 and any vehicles waiting to access the site would be hazardous on this very fast stretch of road.
